CHAIRPERSON'S FOREWORD

Standing Order 200A (1) and (2) of the National Assembly Standing Orders provides that *“(1) A Committee which is unable to complete its work before the expiry of its term shall table an exit report to the Assembly detailing reasons for such inability; and (2) The report shall be available to the succeeding committee which may consider it in preparing its work plan”*.

This Exit Report is a requirement of Standing Order 200A. It documents the activities undertaken by the Departmental Committee on Environment and Natural Resources of the 12th Parliament. It is intended to be a starting point for the subsequent Parliament's successor Committee as it considers its Work Programme. The Report contains all the business transacted by the Committee during the 12th Parliament and the pending business for record purposes. The Report also includes the challenges experienced during its conduct of business and the recommendations thereof.

The following business was referred to the Departmental Committee on Environment and Natural Resources in the Twelfth Parliament: eight (8) Bills; nine (9) Legislative Proposals; twenty-five (25) Petitions; Five (5) inquiries; seventeen (17) Statements; two (2) vetting; and two (2) Sessional Papers. The Committee was able to execute most of the work referred to it despite the challenges that Members had to work under key among them; the COVID-19 Pandemic, which made it difficult to hold in-person meetings.

The Committee was able to positively impact the country in Environment and Natural Resources sector. The Committee, through allocation of funds, was able to oversight the construction of various mega dams that are at an advanced stage of completion. Key among them include: Karimenu II Dam, North Collector Tunnel, Thwake Dam to mention but a few. The Committee through its Report on the Status of Forest Logging in the Country, was able to influence, through its recommendations, allocation of funds towards tree planting to increase to the target 10% tree cover. The Committee has allocated funds to various community-based water projects through programmes like water for schools and Cross-County Bulk Water Projects through which various boreholes and water pans have been constructed for water provision.

It is therefore my pleasant duty and privilege, on behalf of the Departmental Committee on Environment and Natural Resources and pursuant to provisions of Standing Order 200A (1) to present to this House the Exit Report of the Departmental Committee on Environment and Natural Resources.

1 PREFACE

1.1 ESTABLISHMENT OF THE COMMITTEE

1. The Departmental Committee on Finance and National Planning is one of the fifteen Departmental Committees of the National Assembly established under **Standing Order 216** whose mandate pursuant to the **Standing Order 216 (5)** is as follows:

- To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned ministries and departments;*
- To study the programme and policy objectives of Ministries and departments and the effectiveness of their implementation;*
- To study and review all the legislation referred to it;*
- To study, access and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;*
- To investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;*
- To vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order No. 204 (Committee on appointments);*
- To examine treaties, agreements and conventions;*
- To make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;*
- To consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and*
- To examine any questions raised by Members on a matter within its mandate.*

1.2 MANDATE OF THE COMMITTEE

3. In accordance with the Second Schedule of the Standing Orders, the Committee is mandated to consider the following subjects: - climate change, environment management and conservation, forestry, water resource management, wildlife, mining and natural resources, pollution and waste management.

 - a) The Ministry of Environment and Forestry;
 - b) The Ministry of Water & Sanitation and Irrigation;
 - c) The State Department for Wildlife; and
 - d) The Directorate of Mining.

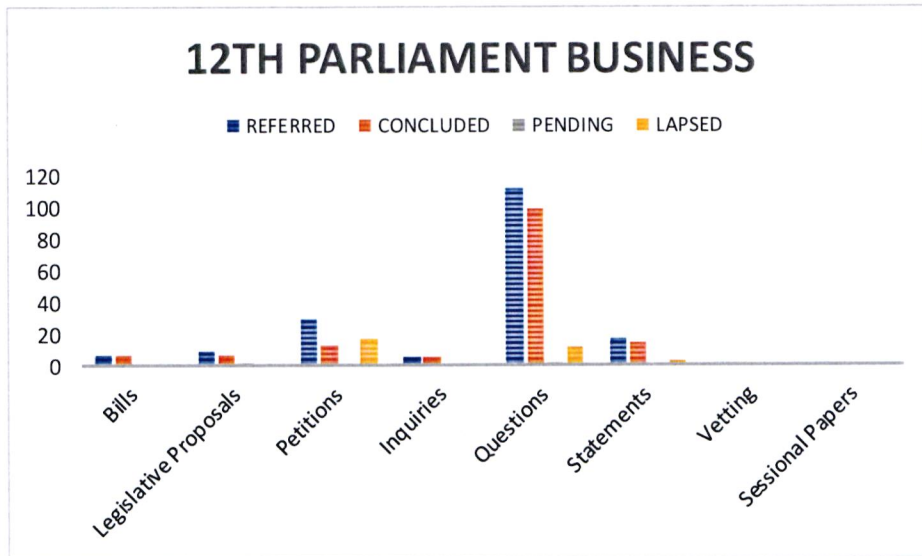

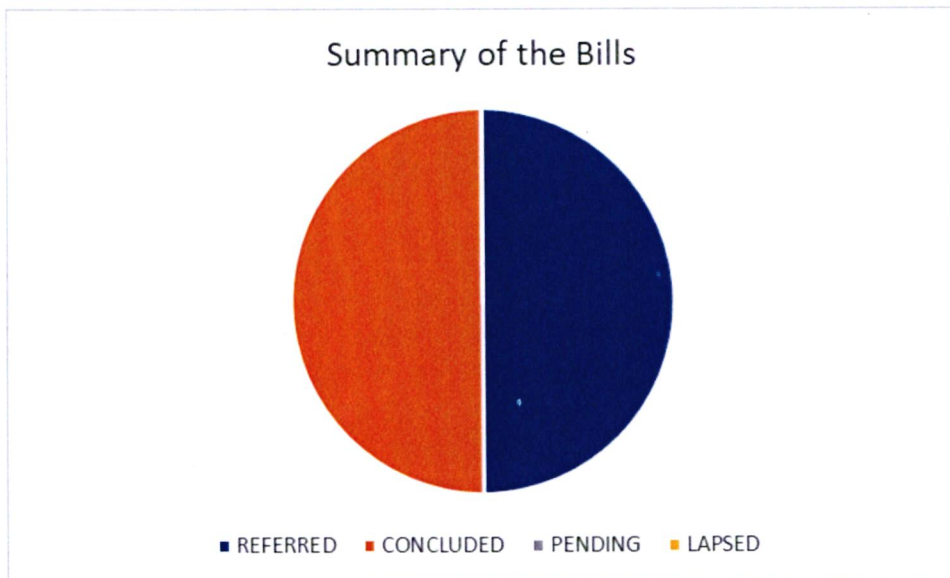

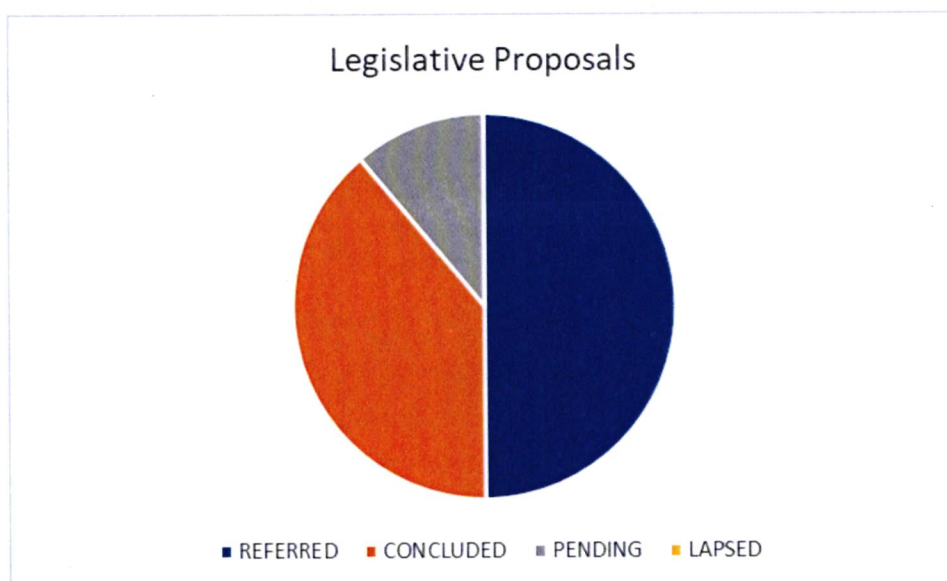

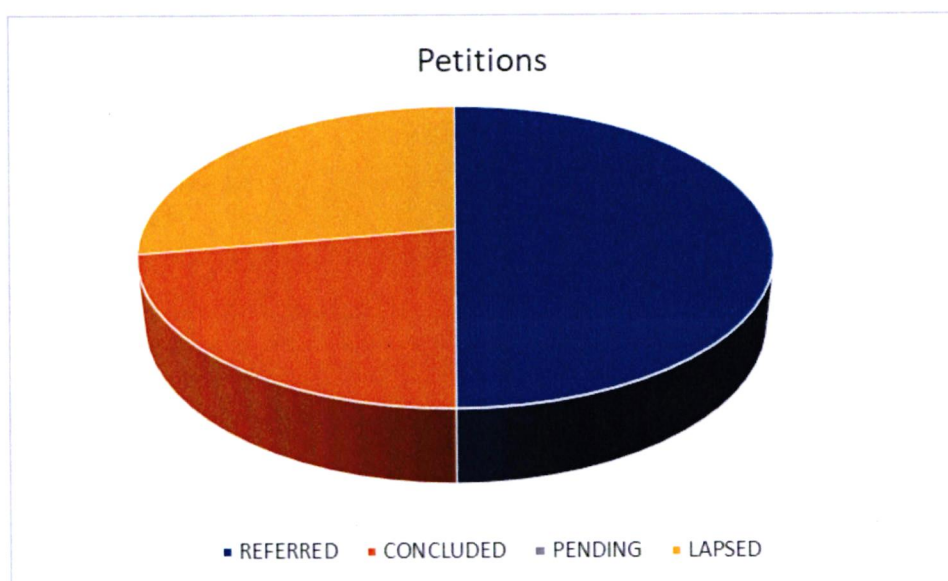
2.2.1 LEGISLATIVE PROPOSALS PENDING BEFORE THE COMMITTEE

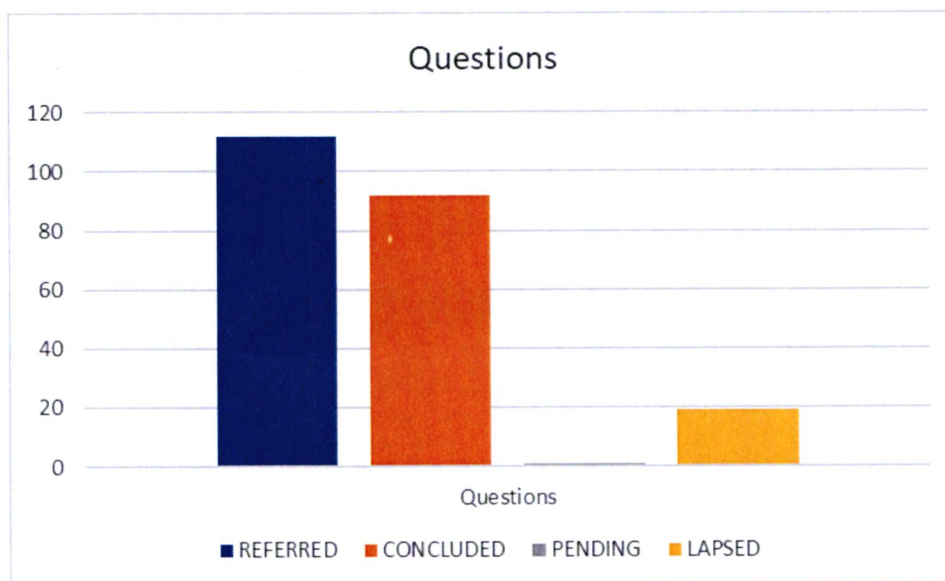
2.4 INQUIRIES

21. The Committee undertook five (5) inquiries during the second and the third Sessions of the Twelfth Parliament and the Reports were concluded, tabled and adopted by the House. The inquiries were aimed at improving addressing various environmental protection and conservation issues. The inquiries undertaken by the Committee are:

- i. An Inquiry into Complaints of Environmental Pollution by London Distillers Kenya Limited;
- ii. An Inquiry into Forest Resources Management and Logging Activities in Kenya;
- iii. An Inquiry into Death of Eleven Rhinos after Translocation to the Tsavo East National Park;
- iv. An Inquiry into the Status of Dams in Kenya; and
- v. An Inquiry into the Encroachment into the Riparian Areas in Kenya.

2.5 QUESTIONS

22. A total of one hundred and eighteen (118) Questions were referred to the Committee for response during the Twelfth Parliament out of which, one hundred and four (104) were responded to, twelve (12) lapsed, one (1) Question was pending before the Committee. The bar graph below gives a summary of the information above.

PART THREE

3 IMPACT OF THE BUSINESS TRANSACTED BY THE COMMITTEE

Some of the impacts that the Committee's work had to the country include:

34. The Committee while exercising its oversight mandate, conducted inquiries on areas affected by air and solid waste management. For instance, the Committee's Recommendation on the Inquiry into the Complaints against the London Distillers, Kenya by the Residents of Athi River, were adopted by the House. The Implementation Committee followed up on the Committee's recommendations on the concerned parties, ensuring that improvement orders from NEMA and recommended mitigation measures were adhered to, to ensure good co-existence between the investors and the residents. Further, the Committee's intervention at the Kibarani Dumpsite facilitated the removal of the dumpsite which was polluting the Indian Ocean hence affecting marine life. This completely changed the ambience around the Kibarani area.
35. The Committee's inquiry into the Logging Activities in Kenya led to a moratorium on illegal harvesting of trees, which was marred with irregularities, hence affecting the Appropriation in Aid flow for the Kenya Forest Service and the overall forest cover. The Ministry of Environment and Forestry, through the recommendation of the Committee, received Kshs. 1 billion towards increasing the forest cover to the targeted 10% tree cover in the FY 2019/2020 Budgetary Allocation.
36. Through the Committee's recommendation to the Budget and Appropriations Committee, the allocation towards the Human Wildlife Conflict Compensation had been increasing from the regular allocation of Kshs. 500 million, which has always been inadequate to Kshs. 1 billion in the FY 2022/2023 to ensure the affected people and their families receive compensation.
37. The Committee considered had considered the Sustainable Waste Management Bill, 2021, which had since been passed by the House and forwarded to the Senate for concurrence. Upon passage by the Senate and assent of the legislation, it will change the handling of waste in the country, introducing circular economy, through which waste will be transformed into raw materials, and hence create employment from the waste industry.

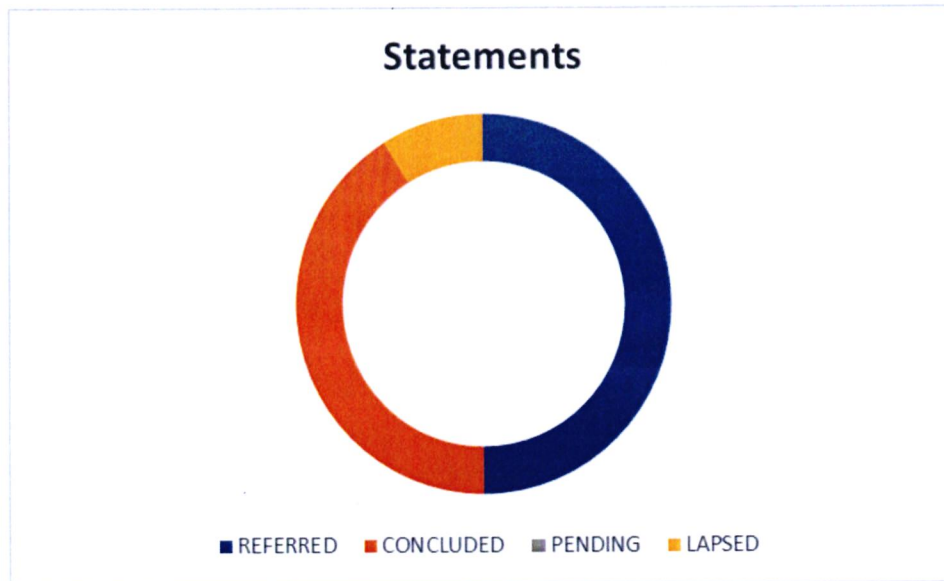

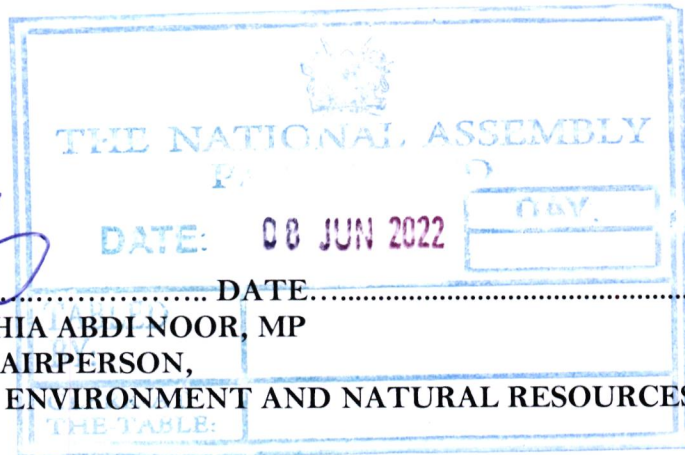

4. Difficulty in raising quorum because of the 2022 General Elections especially in Sixth Session slowed down activities of the Committee.
5. Inadequate committee meeting rooms and furniture occasionally led to delays in starting meetings and at times cancellation of meetings.

The meeting was called to order at 9.45 am after which prayers were said. The Acting Chairperson then stated that the main agenda of the day was consideration and adoption of an exit report of the Committee for the 12th Parliament.

The Members adopted the agenda of the meeting.

Confirmation of minutes of the previous sitting was deferred to the next meeting.

MIN.NO. DC/ENR/132/2022: - CONSIDERATION AND ADOPTION OF AN EXIT REPORT OF THE COMMITTEE FOR THE 12TH PARLIAMENT.

The exit report of the Committee on Environment and Natural Resources for the 12th Parliament was considered and adopted after being proposed by Hon. Nasri Sahal Ibrahim, M.P. and seconded by Hon. Bernard Shinali, M.P.

It was adopted with the following achievements and challenges highlighted:

Achievements

1. The Committee while exercising its oversight mandate, conducted inquiries on areas affected by air and solid waste management. For instance, the Committee's Recommendation on the Inquiry into the Complaints against the London Distillers, Kenya by the Residents of Athi River, were adopted by the House. The Implementation Committee followed up on the Committee's recommendations on the concerned parties, ensuring that improvement orders from NEMA and recommended mitigation measures were adhered to, to ensure good co-existence between the investors and the residents. Further, the Committee's intervention at the Kibarani Dumpsite facilitated the removal of the dumpsite which was polluting the Indian Ocean hence affecting marine life. This completely changed the ambience around the Kibarani area.
2. The Committee's inquiry into the Logging Activities in Kenya led to a moratorium on illegal harvesting of trees, which was marred with irregularities, hence affecting the Appropriation in Aid flow for the Kenya Forest Service and the overall forest cover. The Ministry of Environment and Forestry, through the recommendation of the Committee, received Kshs. 1 billion towards increasing the forest cover to the targeted 10% tree cover in the FY 2019/2020 Budgetary Allocation.
3. Through the Committee's recommendation to the Budget and Appropriations Committee, the allocation towards the Human Wildlife Conflict Compensation had been increasing from the

regular allocation of Kshs. 500 million, which has always been inadequate to Kshs. 1 billion in the FY 2022/2023 to ensure the affected people and their families receive compensation.

4. The Committee considered had considered the Sustainable Waste Management Bill, 2021, which had since been passed by the House and forwarded to the Senate for concurrence. Upon passage by the Senate and assent of the legislation, it will change the handling of waste in the country, introducing circular economy, through which waste will be transformed into raw materials, and hence create employment from the waste industry.

Challenges


1. The COVID-19 pandemic affected the frequency of meetings and it made it difficult to meet stakeholders to prosecute matters before the Committee. This affected the Committee's efficiency in the execution of its mandate.
2. Unavailability of Government officials when invited for meetings to consider business before the Committee. This made it difficult for the Committee to discharge its mandate effectively.
3. Some Members whose business was referred to the Committee were not available when invited for Committee meetings to consider their Questions, Legislative Proposals, Statements or Petitions.
4. Difficulty in raising quorum because of the 2022 General Elections especially in Sixth Session slowed down activities of the Committee.
5. Inadequate committee meeting rooms and furniture occasionally led to delays in starting meetings and at times cancellation of meetings.
