#### SUMARIZED STATUS REPORT ON SUBMISSION OF LIST OF PROPOSED MEMBERS OF NATIONAL GOVERNMENT CONSTITUENCY DEVELOPMENT FUND COMMITTEES FOR GAZETTEMET

The NGCDF Board has to date received lists of proposed members of National Government Constituency Development Fund Committees from **Two Hundred and Sixty (260)** constituencies as follows: -

- And Seventy Two (272)*
- a) **One Hundred and Eighty-One (181)** which have been approved by the National Assembly and gazetted with effect from April 14, 2020 vide *Gazette Notice No. 3737, Contained in Vol. Cxxii-No. 97, published on May 29, 2020 hence term of NGCDFCs will run until April 13, 2022;*
  - b) **Sixty two (62)** which have been submitted to the National Assembly(N.A.) between the dates of April 14, 20, 28 and May 20, 2020 for approval pursuant to Section 43(4) of the NG-CDF Act, 2015;
  - c) **Sixteen(16)** have been analysed and ready for transmission to National Assembly for approval; and
  - d) **Thirteen (13)** are currently being analysed for the Board for compliance to the NGCDF Act and Regulations before presentation to National Assembly for approval.

**Fifteen (15)** constituencies are yet to submit their respective lists and they appear in the first table as Annex I. The Board is coordinating with its officers to fast track submission of nominees for analysis of conformity with the NGCDF Act and its regulations before presentation to the National Assembly for approval

It should also be noted that **Three(3)** constituencies have their terms ongoing as follows: -

- **Baringo South-** *Gazette Notice No. 49, Dated December 30, 2019 Contained in Vol. Cxxii-No. 01, published on January 03/01/2020 hence term of NGCDFC still running until December 2021*
- **Embakasi South-** *Gazetted Via Gazette Notice No. 4856 Dated May, 30<sup>th</sup> 2019, hence term of NGCDFC still running until May 2021*

- **Ugenya- Gazetted Via Gazette Notice No. 7346 Dated August 7<sup>th</sup> 2019, hence NGCDFC term runs until August 2021**

Upon receipt, the submissions are checked as against the checklist given in the Circular issued by the board on the selection process, for conformity with the requirements of the law applicable to NGCDF, Regulations to the NGCDF Act and the said circular.

**Major challenges** faced have been compliance with Regulation 6 on the requirements of fulfilment of residency in the Constituency, Chapter Six and literacy of nominees, with the pending submissions currently at the Board having all or majority of the nominees lacking testimonials showing the same, such as certificates of good conduct, submitted EACC self-declaration forms, academic qualifications and proof of residency in the nominating constituency.
