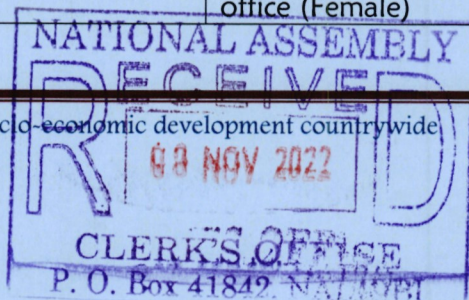
Reference is made to the above matter and our letter Ref: NG-CDFB/CEO-KNA/VOL V (62) dated November 03, 2022.


