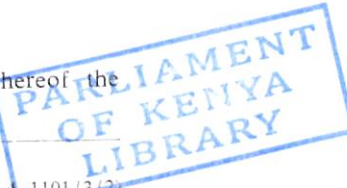

THE KENYA (LOWER HOUSE CONSTITUENCIES)
ORDER IN COUNCIL, 1963

(L.N. 97 of 1963)

IN EXERCISE of the powers conferred by section 2 of the Kenya (Lower House Constituencies) Order in Council, 1963, the Governor hereby makes the following Regulations:—

THE KENYA (LOWER HOUSE CONSTITUENCIES)
REGULATIONS, 1963

1. These Regulations may be cited as the Kenya (Lower House Constituencies) Regulations, 1963.

2. Each of the several areas specified in the third column of the Schedule to these Regulations is hereby constituted a constituency for the purposes of elections to the proposed Lower House, and shall, for that purpose have the name and number specified opposite it in the first and second columns respectively of that Schedule.

3. In the Schedule to these Regulations, "Extra-Regional Area of Nairobi" means the Extra-Regional Area of Nairobi constituted by the Kenya (Regions and Districts) Regulations, 1963, and a reference to a particular district, except where the context otherwise requires, means the district of that name constituted by those Regulations.
