**RE: GAZETTE NOTICE  
CRITERIA FOR DETERMINATION OF ELECTRICITY REBATE AS PER THE  
FINANCE ACT (NO. 10 OF 2018)**

In a bid to encourage enhancement of Big Four Agenda so as to spur socio-economic development, the Government intends to implement the electricity cost rebate programme.

Section 7 of the Finance Act, 2018 amended section 15 of the Income Tax Act to provide for 30% rebate entitlement on electricity cost incurred by manufacturers in addition to the normal electricity expense.


The said rebate was subject to conditions set by this ministry. To this end and through a consultative process, we prepared the conditions and criteria aforementioned, as per the attached gazette notice, which was published on 31<sup>st</sup> July, 2019.
