## 1.0 PREFACE

**Mr. Speaker, Sir,**

The Constituencies Fund Committee is a Select Committee of Parliament constituted pursuant to Section 27 (1) of the Constituencies Development Fund (Amendment) Act, 2007.

Its mandate pursuant to Section 27 (4) is:-

- (a) *to determine the allocation and distribution to each constituency and the utilization of any unspent funds intended for use by the Board;*
- (b) *to consider and report to Parliament, with recommendations, names of persons required to be approved by Parliament under the Constituencies Development Fund Act;*
- (c) *to consider and recommend to Parliament any matter requiring action by the National Assembly pursuant to the provisions of the Constituencies Development Fund Act;*
- (d) *to oversee the implementation of the CDF Act and in this respect, shall after every two years submit a report to the National Assembly and where necessary, propose any amendments to this Act, in particular, with respect to the quantum of funds repayable into the Fund in accordance with section 4 of the Act.*
- (e) *to oversee the policy framework and legislative matters that may arise in relation to the Fund;*
- (f) *to continually review the framework set out for the efficient delivery of development programmes financed through the Fund; and*
- (g) *to carry out any other functions relevant to the work of the Fund.*



## 2.0 BACKGROUND AND CONTEXT

The Constituencies Development Fund Board is established pursuant to Section 5 of the CDF (Amendment) Act, 2007.

The Board of Management consists of:-

- a) The Permanent Secretary of the Ministry of Planning or his designated alternate, not being below the level of Director of Planning;
- b) The Permanent Secretary of the Ministry of Finance or his designated alternate, not being below the level of Director of Budget;
- c) The Attorney- General or his designated alternate not being below the level of Senior State Counsel;
- d) Eight persons qualified in matters relating to finance, accounting, engineering, economics, community development, or law. The eight are nominated by organizations listed in the First Schedule. The organizations are as follows:-
  - i. The Kenya National Federation of Agricultural Producers
  - ii. Institute of Engineers of Kenya
  - iii. The Kenya National Chamber of Commerce and Industry
  - iv. The Kenya Episcopal Conference
  - v. The Kenya National Union of Teachers
  - vi. The National Council of Churches of Kenya
  - vii. The Supreme Council of the Kenya Muslims
  - viii. The Institute of Certified Public Accountants of Kenya
- e) Four persons, qualified in accordance with paragraph (e) , appointed by the Minister to achieve regional imbalance that may not have been achieved pursuant to the process under subsection (5)
- f) The Chief Executive Officer who shall be an ex-officio member and Secretary to the Board.

The term of the Constituencies Development Fund Board that was constituted on 30<sup>th</sup> April, 2008 expired pursuant to the CDF (Amendment) Act, 2007 Sixth Schedule (1) which states the Chairperson or a member of the Board shall hold office for a period of three years and shall be eligible for appointment for not more than two consecutive terms.

Section 27(4) (b) expressly vests on the Committee, the responsibility of considering and reporting to Parliament, with recommendations, names of persons required to be approved by Parliament under the Act and considering and recommending to Parliament any matter requiring action by the National Assembly pursuant to the provisions of the Act.

On 8<sup>th</sup> September 2011, the House approved the appointment of eight (8) out of ten (10) CDF Board nominees submitted to the Committee by the Minister for Planning, National Development and Vision 2030. The Minister gazetted the appointment of the eight (8) successful nominees on 16<sup>th</sup> September, 2011.

The Committee found two nominees ineligible for appointment for the following reasons:-

**i. Nomination of Mrs. Faith Jebet Chilgong as a Member of the CDF Board**

The Committee found the nominee not qualified for appointment pursuant to Section 5(5) because the nominating organisation, Kenya National Federation of Agricultural Producers (KENFAP) contested her nomination.

The Committee therefore recommended that the Minister sorts out the nomination issue with the nominating body and satisfies the Committee that indeed the nominee was duly nominated by the Kenya National Federation of Agricultural Producers.

**ii. Nomination of Mr. Adow Abdullahi Barrow as a Member of the CDF Board**

The nominee was nominated by the Minister for Planning, National Development and Vision 2030 pursuant to Section 5 (3) (f). He was found wanting on his limited knowledge of CDF operations.

The Committee recommended that the Minister submits another nominee for appointment to the CDF Board.

On 16<sup>th</sup> February, 2012, the Minister for Planning, National Development and Vision 2030, submitted names of two nominees for CFC's concurrence in appointing them as CDF Board members. The two nominees are:-

Having received the names, the Committee embarked on vetting the two nominees with the objective of determining their suitability for appointment as Constituencies Development Fund Board Members.

### 3.0 CONSIDERATION OF THE NOMINEES BY THE COMMITTEE

On 8<sup>th</sup> March, 2012 and 12<sup>th</sup> March, 2012, The Committee examined the nominees against the criteria set out in the Schedule to the *Public Appointments (Parliamentary Approval) Act, 2011*. The criterion requires nominees to disclose information on their personal and professional life including their political affiliations, tax compliance and potential conflict of interests and other things.

#### 1.0 Nomination of Mr. Boniface Lokaale Korobe

Mr. Korobe was nominated pursuant to Section 5 (3) (f) of the CDF (Amendment) Act, 2007 by the Minister for Planning, National Development & Vision 2030 to achieve regional balance that was not achieved pursuant to the process under sub-section 5.

The Committee having considered the curriculum vitae of Mr. Boniface Lokaale Korobe and having heard his submissions during the interview, made the following observations on his nomination for appointment as member of the CDF Board:

- He is a Kenyan citizen born in 1975 and hails from Turkana County.
- He holds a Bachelor of Arts degree in Anthropology from the University of Nairobi.
- He worked as a CDF Project Coordinator for the Turkana North CDF in 2004.
- He has many years of experience in community development having worked extensively in arid Kenya with OXFAM-GB and Arid Lands Resource Management Project.
- He has complied with his tax obligations.
- The nominee demonstrated good knowledge of the CDF and some of the challenges facing the Fund and is therefore qualified for appointment as a CDF Board Member.

**The Committee found the nominee qualified for appointment as a CDF Board member and recommends his appointment to the CDF Board.**



### 3.2 Nomination of Mrs. Phoebe Anyango Ngode

Mrs. Ngode was nominated pursuant to Section 5(5) of the CDF (Amendment) Act, 2007 by the Kenya National Federation of Agricultural Producers (KENFAP).

The Committee having considered her curriculum vitae and heard her submissions during the interview, made the following observations on her nomination for appointment as member of the CDF Board:

- She is a Kenyan citizen born in 1962 in Homa Bay County.
- She is the National Women representative of the Kenya National Federation of Agricultural Producers (KENFAP).
- She holds various positions in her community e.g Clan Elder, Locational Development Committee, HIV/AIDS Counsellor and a community health worker.
- She sits in the Board of various schools e.g Chairlady of Luora Secondary School, BoG member of Chiepe Mixed Secondary School, BoG Member of Manga Mixed School, and PTA Chairperson of Onyege Mixed Secondary School.
- She is also the Vice Chairperson of Agricultural Training Centre, Homa Bay.
- She has fully complied with her tax obligations to the state.
- The Committee noted that the nominee had limited understanding of CDF and is therefore not qualified to hold the position of CDF Board Member.

**The Committee found the nominee not qualified for appointment as a CDF Board member and recommends that the Minister for Planning, National Development & Vision 2013 submits another nominee for appointment to the CDF Board.**

#### **4.0 RECOMMENDATIONS BY THE COMMITTEE**

The Committee having considered the curriculum vitae and interviewed the nominee under Section 5(6) of the Constituencies Development Fund ( Amendment) Act, 2007 makes the following unanimous recommendation to the House:-

**THAT,** this House approves the appointment of Mr. Boniface Lokaale Korobe as a Member of the Constituencies Development Fund Board.
