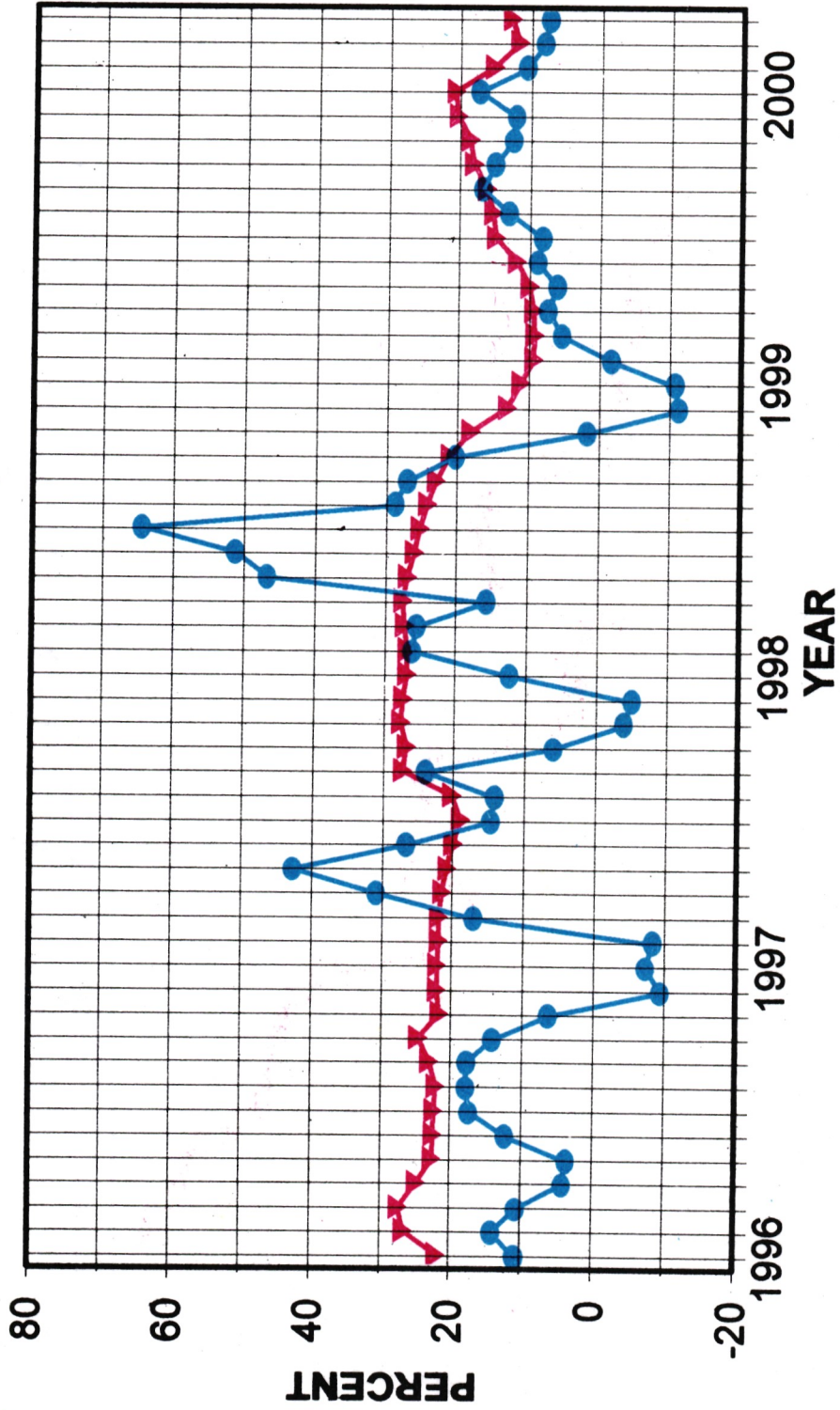

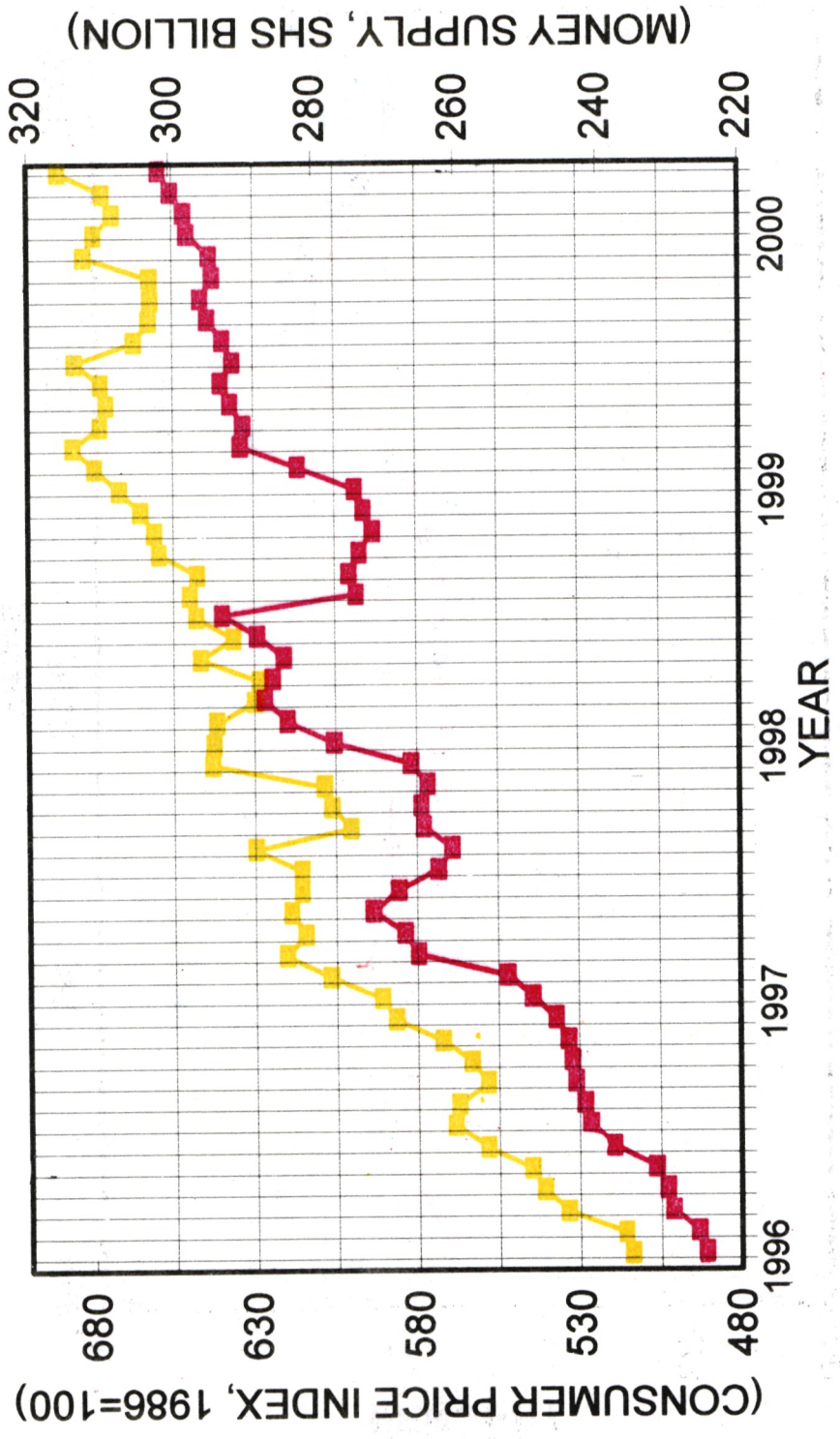

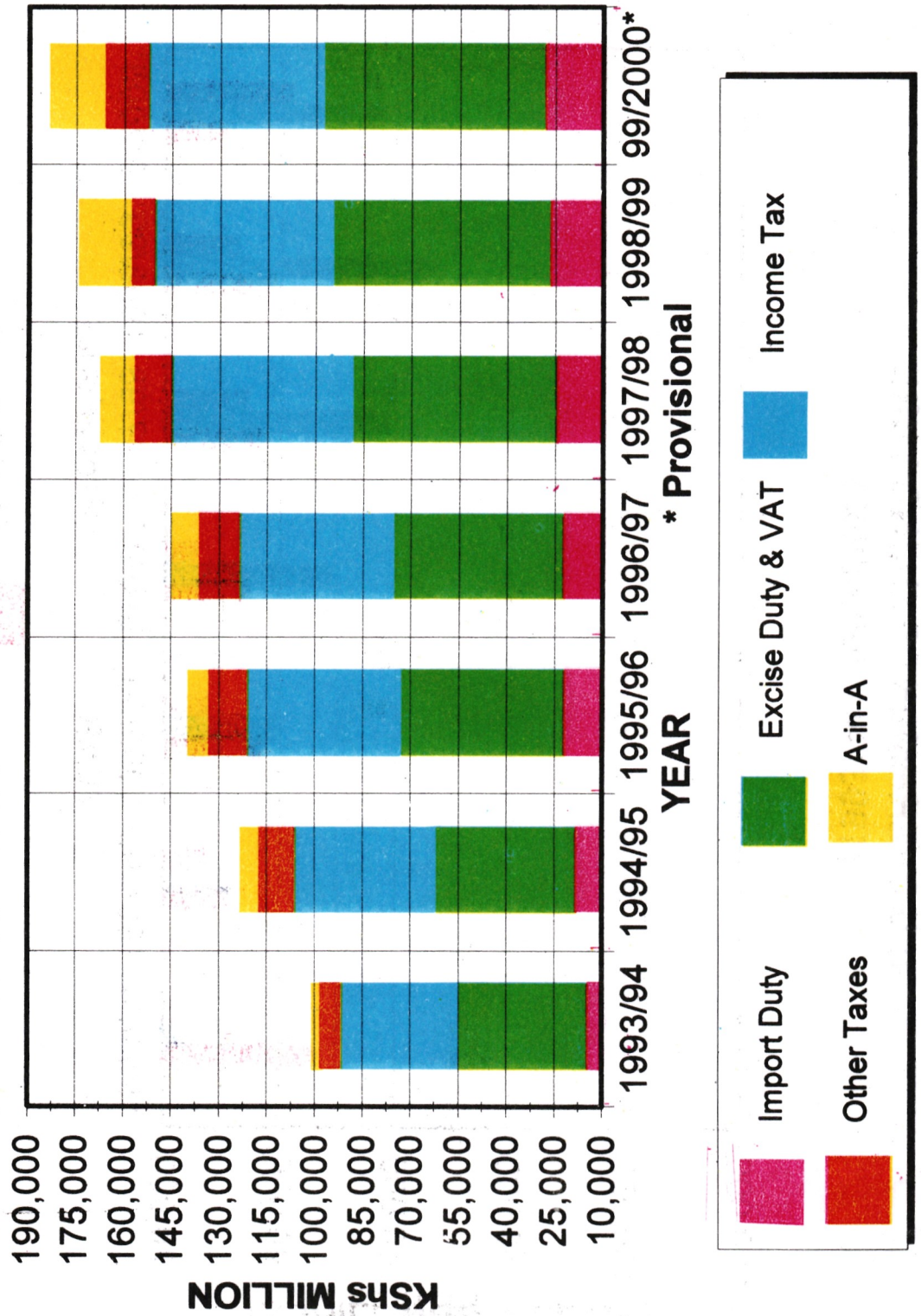
**1: TREASURY BILL YIELD RATES
(MONTHLY AVERAGES)**



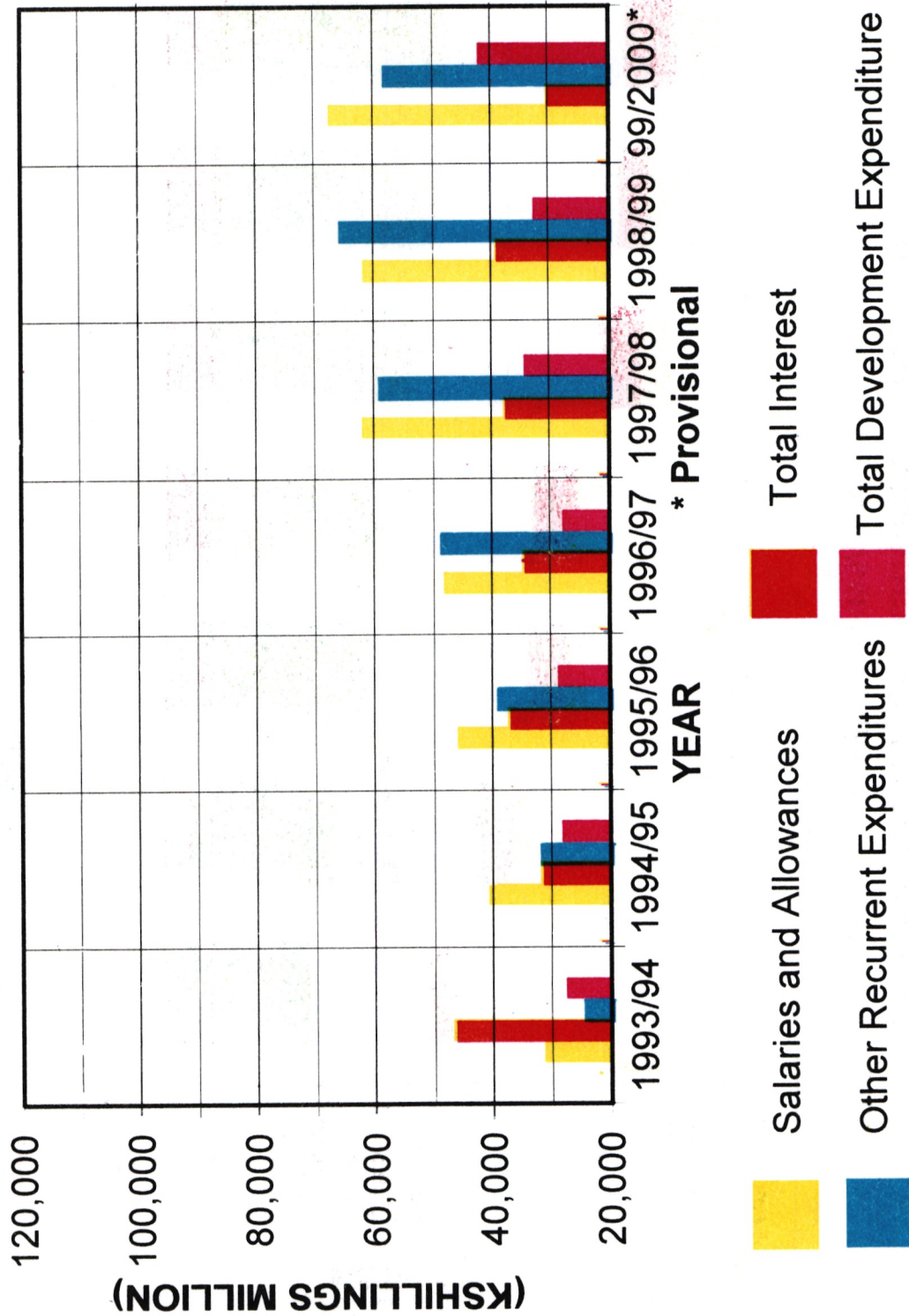
2: CPI INDEX AND MONEY SUPPLY (M3)



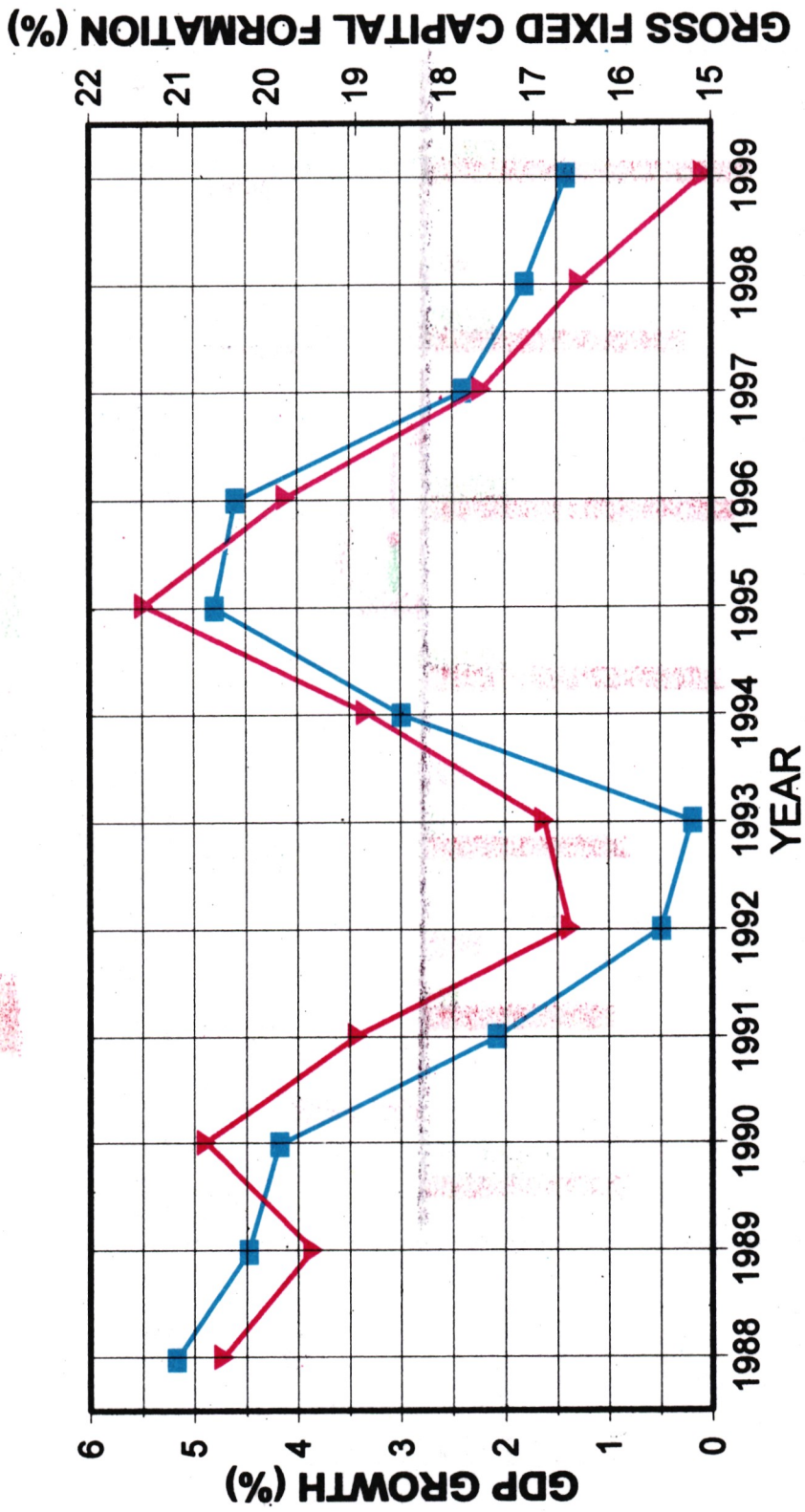
3: ANALYSIS OF GOVERNMENT REVENUE (1993/94 - 1999/2000)



4: GOVERNMENT EXPENDITURE (1993/94 - 1999/2000)

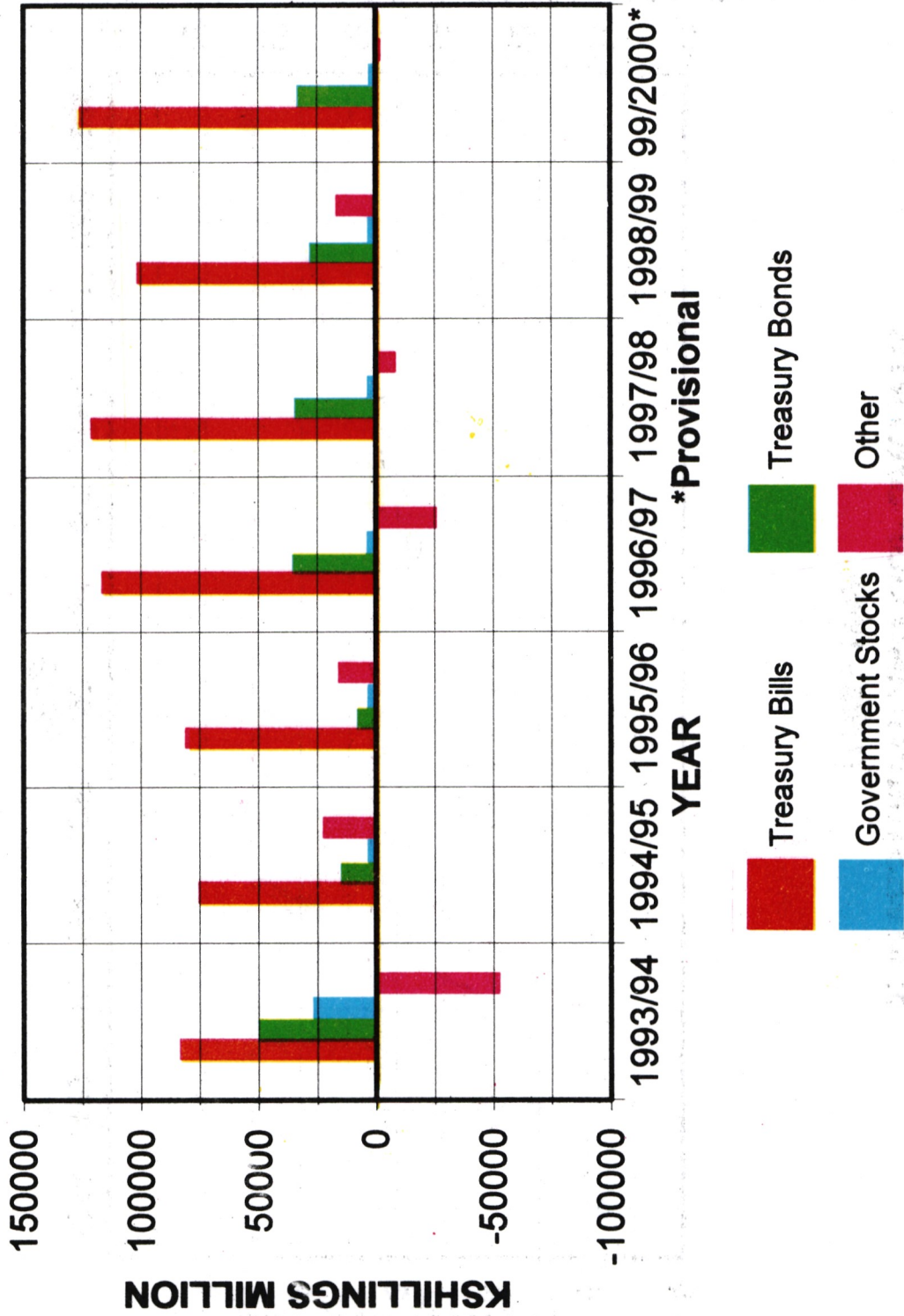


5: INVESTMENT AND GDP GROWTH (1988 - 1999)

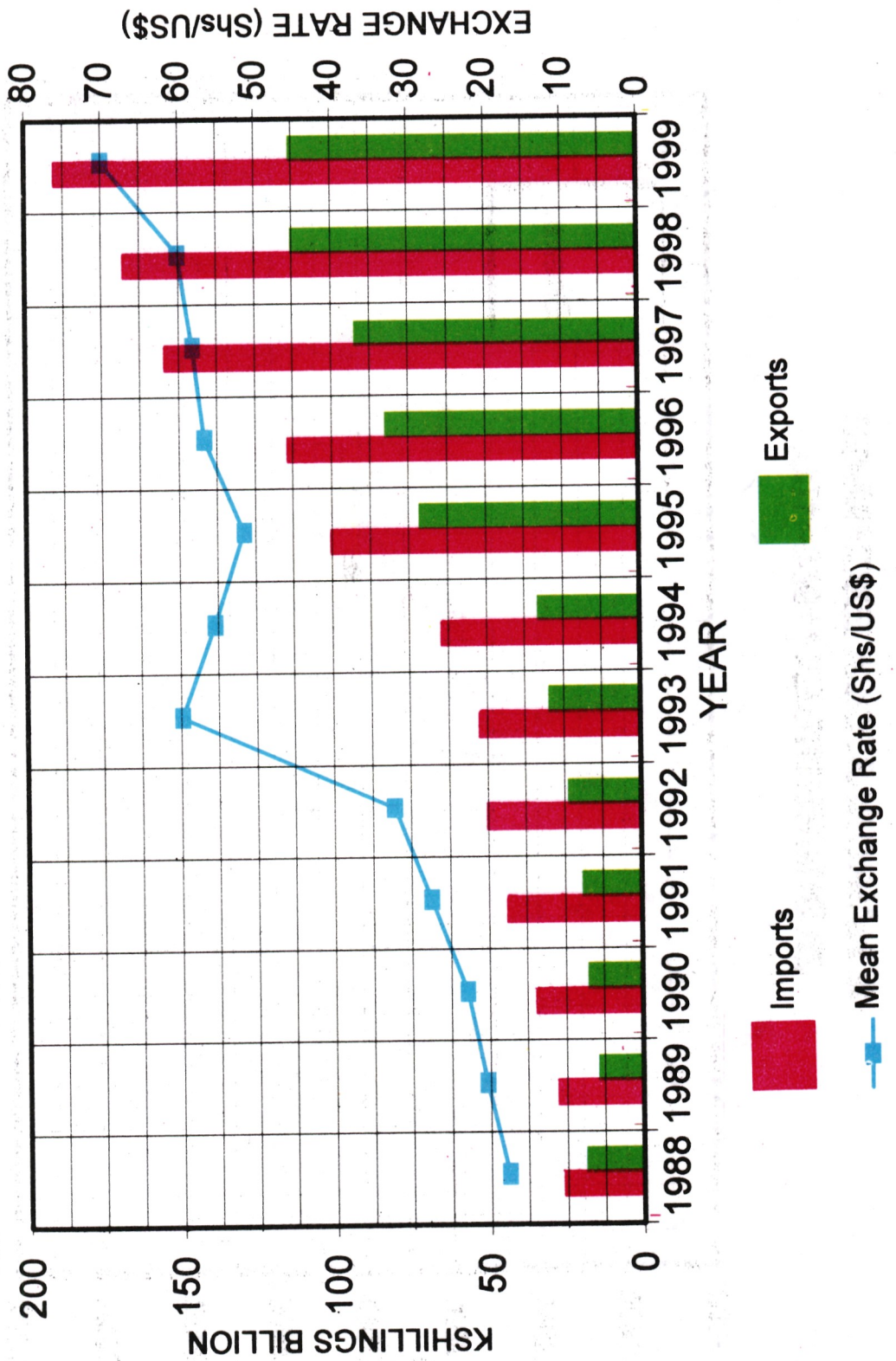

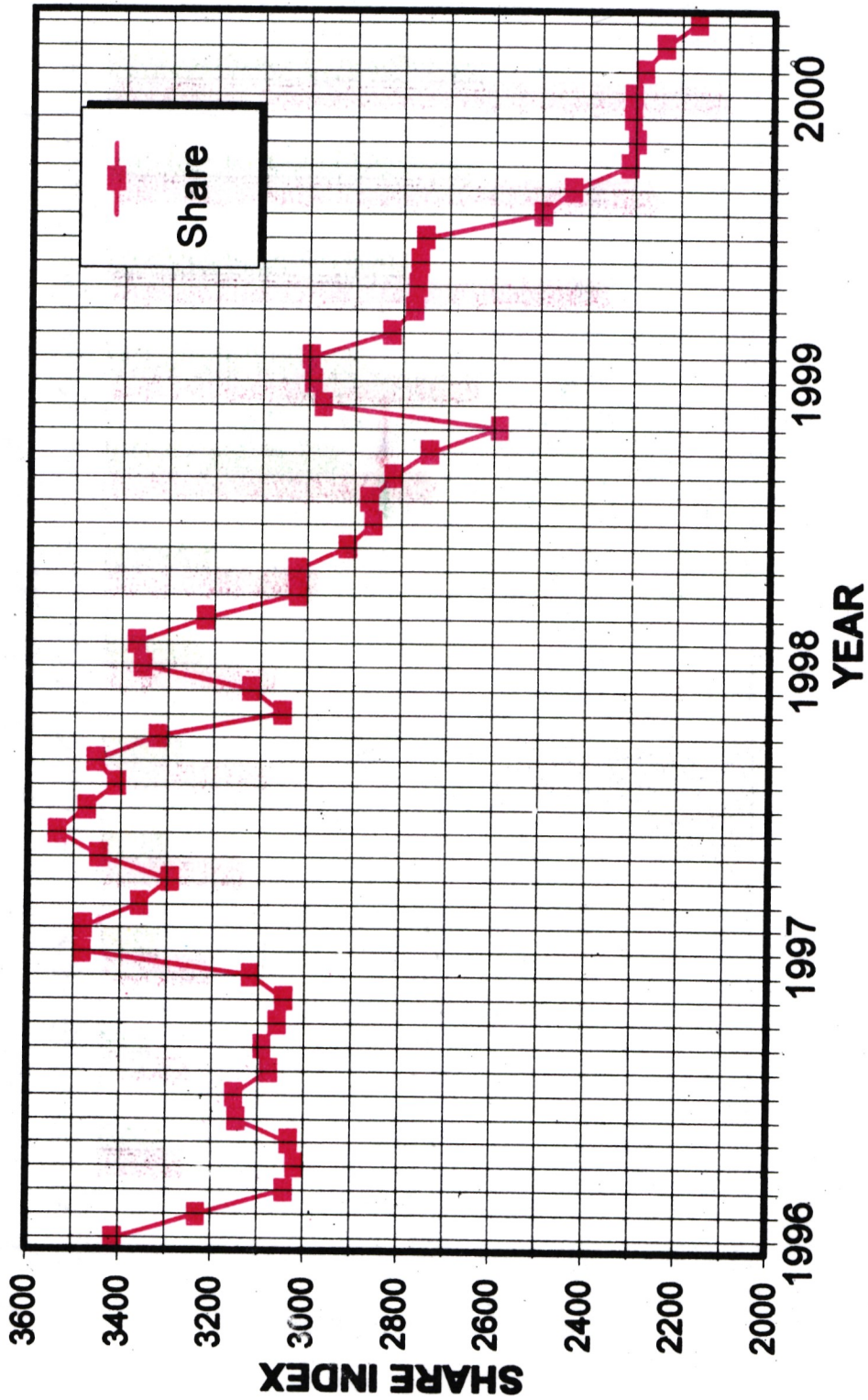
6: GOVERNMENT DOMESTIC DEBT (1993/94 - 1999/2000)



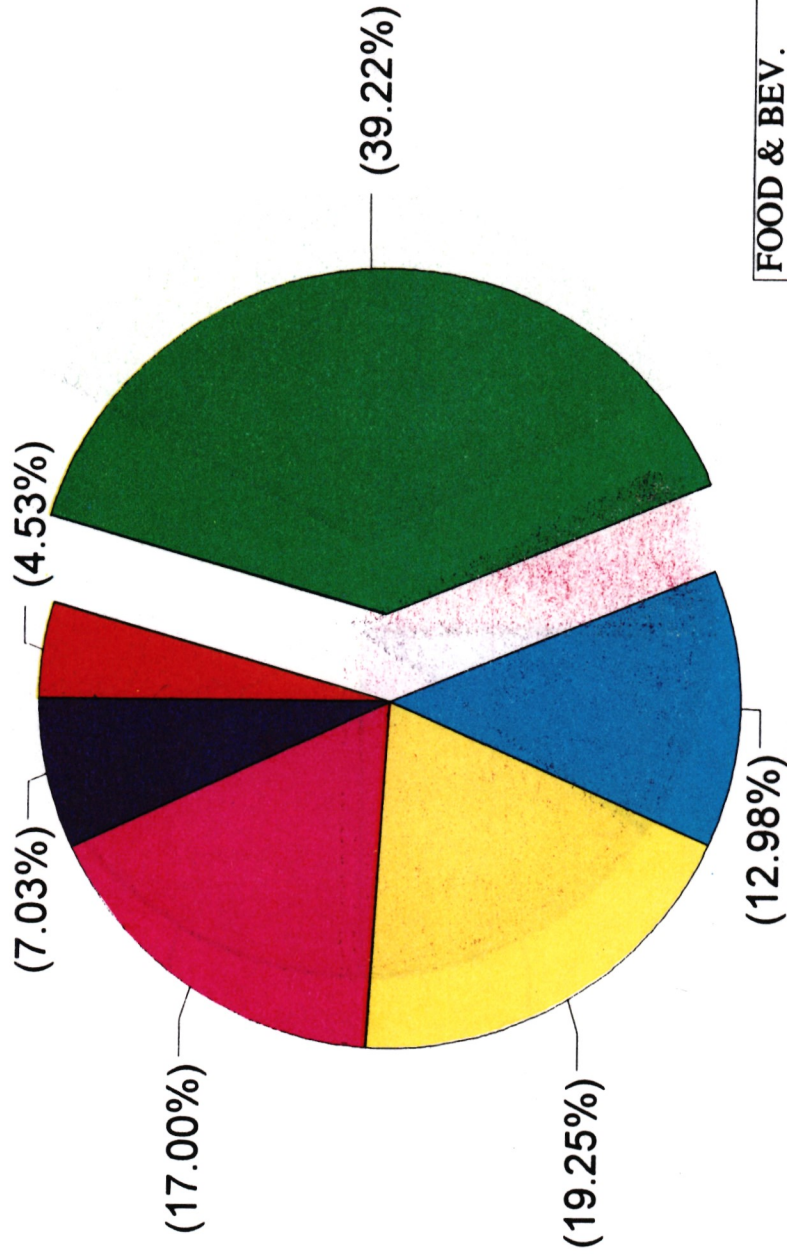
7: IMPORTS & EXPORTS (1988 - 1999)

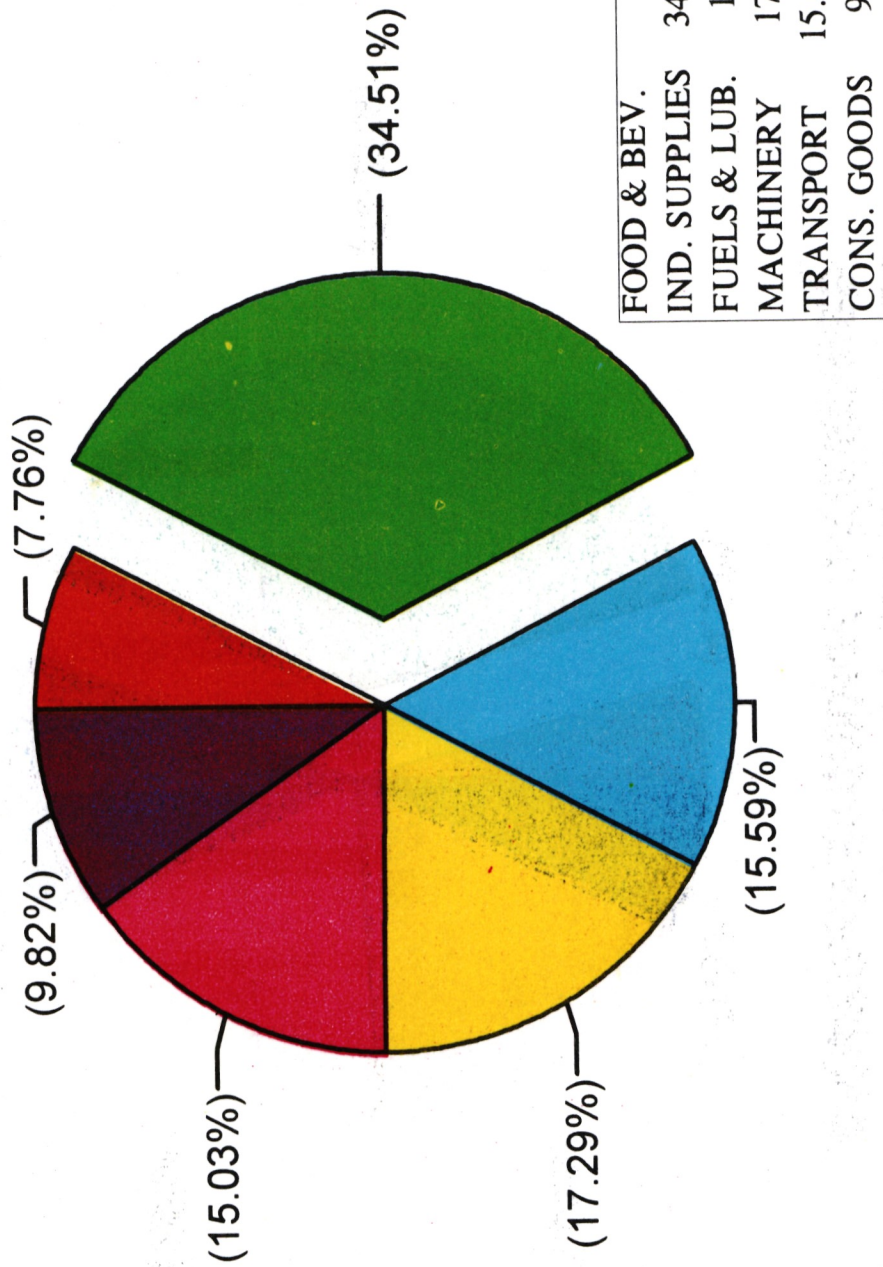


**9A: COMPOSITION OF IMPORTS, 1995
BY BROAD ECONOMIC CATEGORIES**

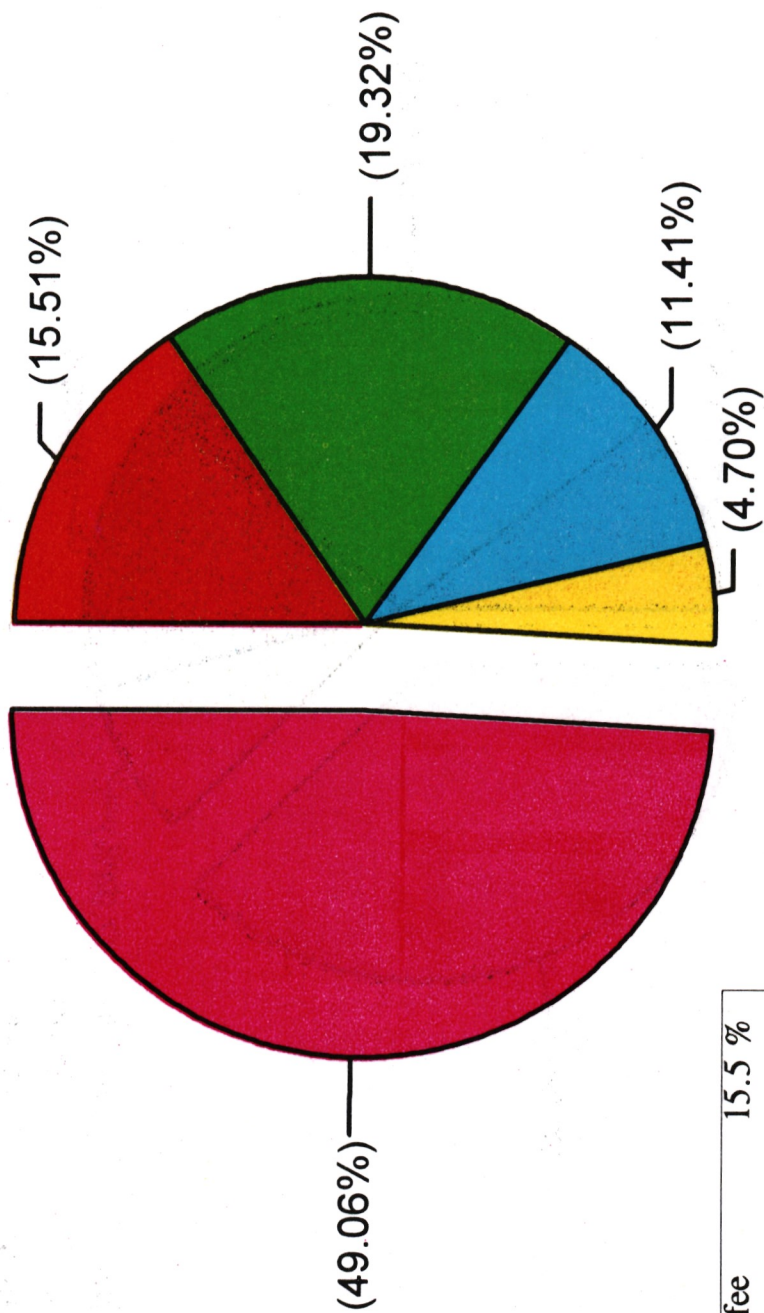

BY BROAD ECONOMIC CATEGORIES**

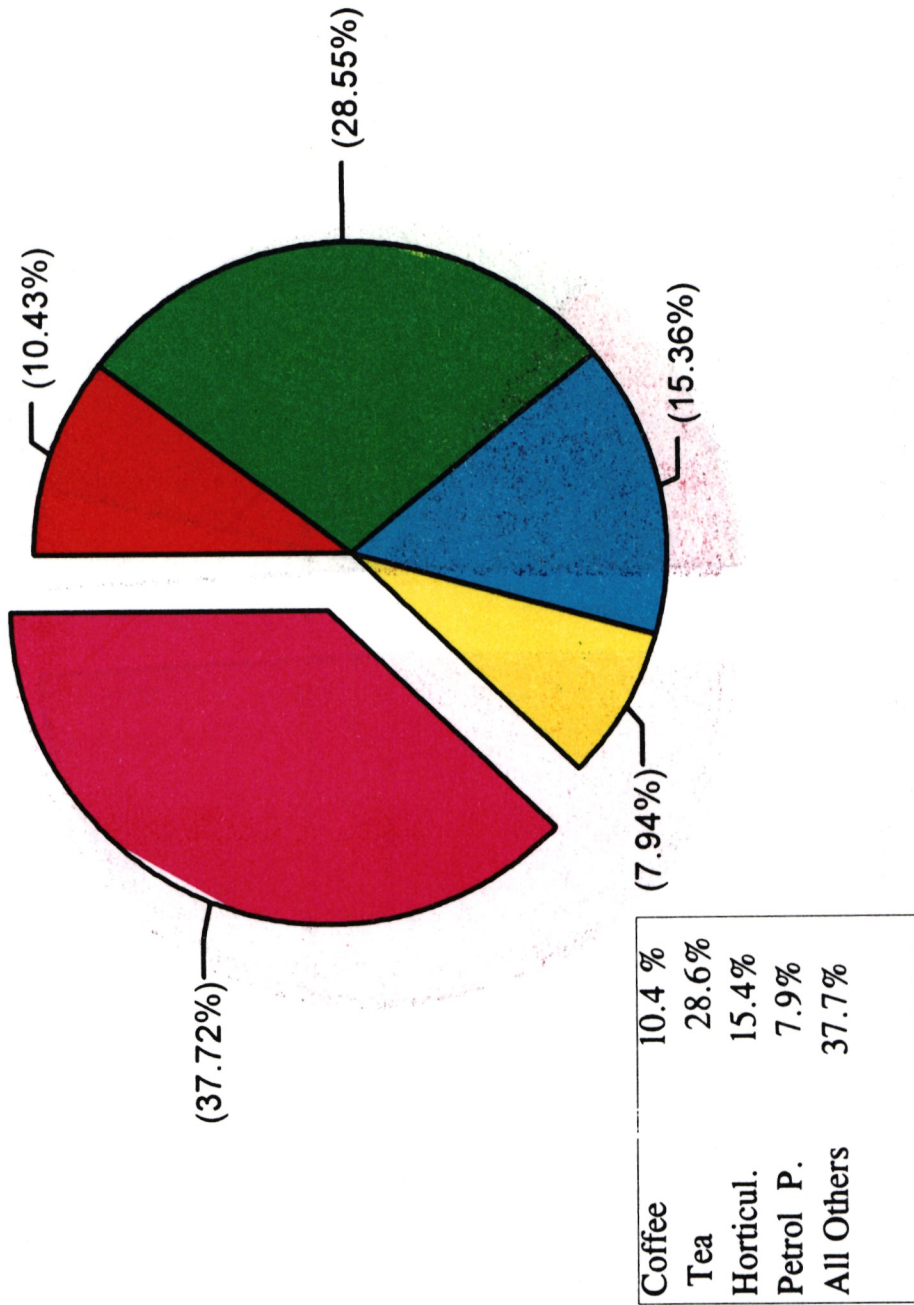


**10A: COMPOSITION OF EXPORTS, 1995
BY PRINCIPAL COMMODITIES**

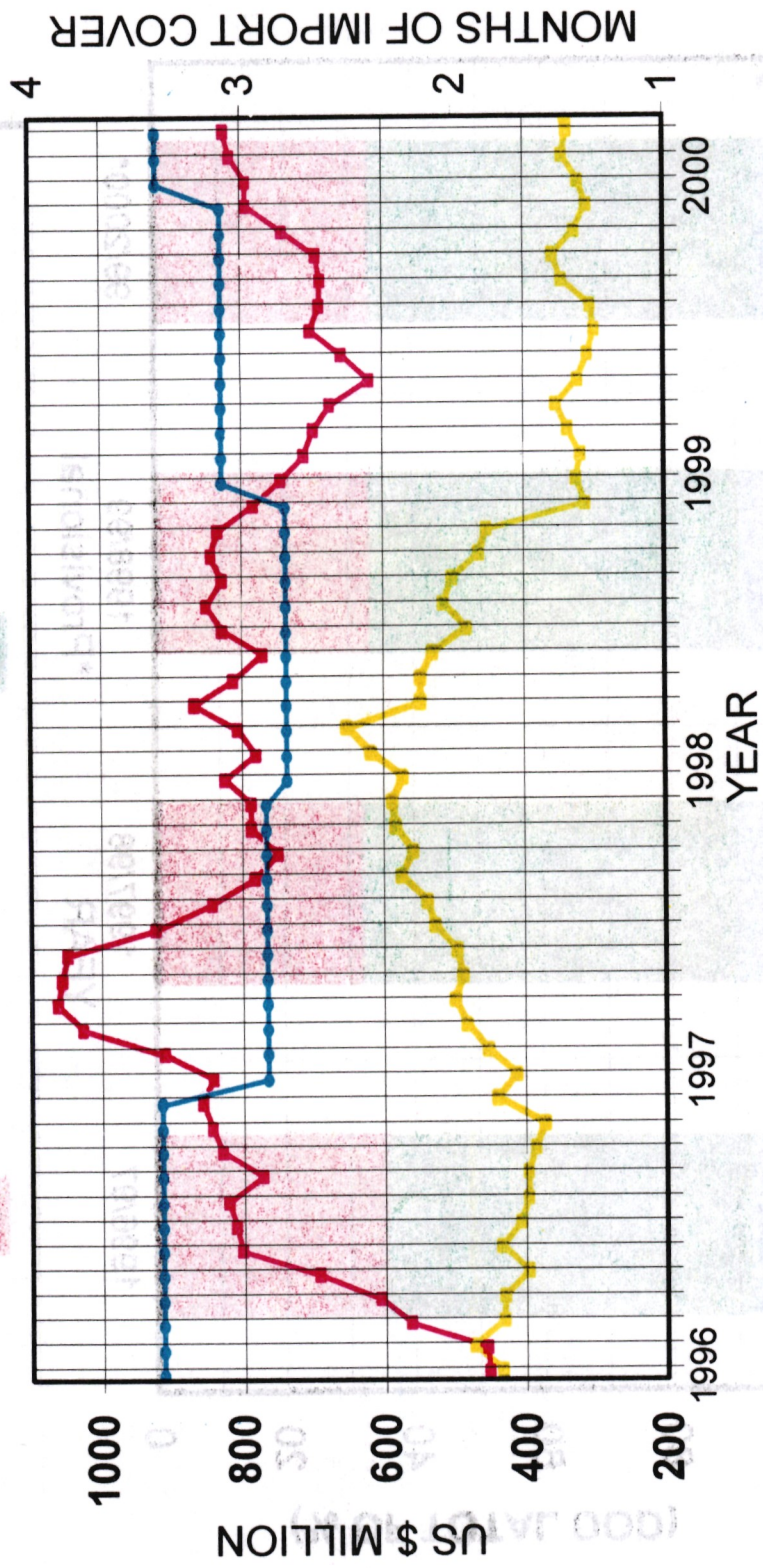
