#### PREFACE

#### Mandate and Functions of the Committee

Article 124 of the Constitution of Kenya, provides for the establishment of Committees by either House of Parliament. Committees are central to the workings, roles and functions of Parliament as set out in Article 94 and more specifically in Article 96 of the Constitution as regards the Senate.

Parliamentary committees consider policy issues, scrutinize the workings and expenditure of the national and county governments and examine proposals for legislation. The roles of committees are twofold, investigative process and deliberative process. The end results of these processes are reports to the House in plenary on inquiry of certain issues under the mandate of a particular committee.

The Standing Committee on Finance and Budget is established pursuant to section 8 of the Public Finance Management Act, 2012 and standing order 212(3) of the Senate Standing Order and is mandated –

- *a)* To investigate, inquire into and report on all matters relating to coordination, control and monitoring of the county budgets and to examine
  - *i) the Budget Policy Statement presented to the Senate;*
  - *ii) report on the Budget allocated to Constitutional Commissions and independent offices;*
  - *iii) the Division of Revenue Bill, County Allocation of Revenue Bill, and cash disbursement schedule for county governments.*
- b) To consider all matters related to resolutions and Bills for appropriations, share of national revenue amongst the counties and all matters concerning the National Budget, including public finance and monetary policies and public debt, planning and development policy and
- c) To pursuant to Article 228 (6) of the Constitution, to examine the report of the Controller of Budget on the implementation of the budgets of county governments.

#### **EXECUTIVE SUMMARY**

The County Statistics Bill (Senate Bill No. 14 of 2018) was sponsored by Sen. Farhiya Haji Ali, and published on 15<sup>th</sup> March, 2018. The bill was read a First Time on 10<sup>th</sup> May, 2018. Following the First Reading, the Bill, stood committed to the Standing Committee on Finance and Budget pursuant to standing order 134 (1) of the Senate Standing Orders.

Subsequently, the Committee considered the Bill and resolved to subject it to public hearings pursuant to Article 118 of the Constitution and Standing Order 134 (5). The Committee invited submissions from members of the public on the Bills via advertisements on the newspapers. The Committee also invited the Council of Governors, Kenya Institute of Public Policy and Research Analysis (KIPPRA) and Ministry of National Planning.

The Committee received written submissions on the Bills and held a public hearing on 30<sup>th</sup> May, 2018. The Ministry Planning through Kenya National Bureau of Statistics (KNBS), Council of Governors, International Budget Partnership (IBP-K) and Kenya Institute of Public Policy and Research Analysis (KIPPRA) raised concerns with some provisions and proposed changes to the bill.

The Committee thereafter, considered all the views raised by the stakeholders and proposed changes. Consequently, the Committee proposed amendments to the Bill as attached annex 1.

#### I. CHAPTER ONE: INTRODUCTION

The County Statistics Bill, 2018 was sponsored by Sen. Farhiya Haji, and published on 15<sup>th</sup> March, 2018. It was read a First Time on 10<sup>th</sup> May, 2018.

The principal objective of this Bill is to put in place a framework for the collection, analysis and dissemination of statistical information by the county governments

Statistics are an important part of the planning process for any government and they also act as a yardstick for governments to determine whether they are meeting their goals in providing services to their people.

This Bill therefore seeks to establish a county statistical system that will assist county governments to plan for the development of counties and to measure the gains made by the county governments in improving the lives of the people in the counties.

The collection of statistics is governed by the Statistics Act (Cap 112) which was enacted prior to the promulgation of the constitutional framework, Constitution of Kenya, 2010. Notably, Part 2 of the Fourth Schedule to the Constitution provides for county statistics as one the functional areas of county governments. The Bill therefore seeks to provide a legal framework for counties to collect, collate and analyse data that is specific to a particular county in order to enhance planning and decision making in the counties.

The Bill provides for the establishment of a county statistics office in every county, which shall be responsible for among others-

- (a) collecting, compiling, analyzing, abstracting and disseminating statistical information on the functions devolved under Part 2 of the Fourth Schedule to the Constitution;
- (b) ensuring coordination of the operations county government bodies involved in the compilation and dissemination of statistics and related information with particular regard to-

- (i) the avoidance of duplication in the collection of statistical information;
- (ii) the attainment of compatibility and the integration of statistics compiled by official bodies; and
- (iii) the maximum possible utilization for statistical purposes of information and means of collection of information available to official bodies;
- (c) advising the county government on all matters related to the use and development of statistical information;
- (d) providing liaison between the national government and county government on matters relating to statistics;
- (e) coordinating the county statistical system;
- (f) developing and using statistical standards and appropriate methodologies, subject to the direction of the committee, in the county statistical system; and

monitoring the technical quality of official statistics and promoting adherence to good practices and international recommendation and standards.

The bill proposed:

- a) that the county statistician who shall be the head of the county statistics office is to be recruited competitively and appointed by the county public service board. The county statistician.
- b) a forum for consultation and coordination in matters relating to statistics since both levels of government have a role in the collection, analysis and dissemination of statistical data in the country
- c) that the county statistics offices should ensure access to statistical information to the public pursuant to the Access to Information Act, No. 31 of 2016,
- d) that the Bill requires the county executive committee member who is responsible for statistics in the county to prepare an annual report to the Governor, which is to be disseminated to the public and tabled in the Senate and the relevant county assembly.

#### II. CHAPTER TWO: STAKEHOLDERS' SUBMISSION

The Committee further received written and oral submissions on the County Statistics Bill, 2018 as follows-

#### Submissions from the KIPPRA

The representative of the Kenya Institute of Public Policy and Research Analysis (KIPPRA) attended the meeting and made submissions as follows:

- a) The bill was to ensure that it promotes efficiency and consistency in the data collection as well as synergies between national and county government levels in implementing the 4<sup>th</sup> Schedule of the constitution;
- b) A clear policy framework would have played a key role in guiding such critical law as well as reviewing the Statistical Act, 2006;
- c) There was need for a well-planned coordination between national statistics and the county statistics by providing a clear mechanism to ensure efficiency, quality and timelines were not compromised especially where international standards and codes were required to be utilised;
- d) The Statistics Act which was under review needed to be aligned with the provisions in the County statistics bill;
- e) To ensure cost effectiveness the counties should adopt the already existing KNBS infrastructure including the international statistical systems and the human capital expertise;
- f) Clause 8 provided for consultative Committee which appeared as an independent organ with policy and oversight roles.
  - That introduced another layer of statistical administration of which it was not clear how its decisions would reach the counties.



- ii) Proposed that the role should remain within the county executive with proper coordination with KNBS.
- g) Clause 12(5) failed to recognise that statistical standards and procedures were set internationally, like common wealth countries statistical standards and procedures. The county statistician should only adopt the existing standards and procedures;
- h) Clause 14 its application would stifle statistic collection and analysis in the county. Secondly, three months' notice requirement may delay and make research work cumbersome and expensive;
- i) Clause 18(2) it was not clear why the county statistics report would be shared with KNBS. Further, how would the discrepancies and aspects of timeliness be resolved?
- j) The role of county assembly in statistical process was not well defined other than receiving the annual reports;
- k) The role of counties during periodic national surveys was not defined; and
- Proposed amendments of Statistic Act, 2006 to strengthen KNBS and mandate it to decentralize and coordinate counties to collect statistics. Further, provide mechanism to link county statistics with national statistics.



#### Submissions from the KNBS

The representative of the Kenya National Bureau of Statistics (KNBS) attended the meeting made their submissions on the bill as indicated herein.

- a) the bill was important in that it aimed at providing establishment of county statistics which was a critical unit at county level;
- b) production of accurate statistics was important since they facilitate proper planning;
- c) the bill had a few issues which they proposed amendments as follows
  - *i)* clause 4(c) be amended to replace 'official bodies' with 'coordinating the operations of the county in compilation and dissemination of statistics and related information with particular regard to'
  - ii) clause 8
  - ✓ replace the name of the Committee with 'Inter-Governmental Consultative Committee on Statistics'
  - ✓ (a) should be deleted since the Committee was technical: county governor need not be the Chairperson.
  - ✓ (b) principal Secretary, State Department responsible for Statistics to chair the Committee
  - ✓ (4) be deleted since KNBS may not be in a position to provide resources to support the Committee.
  - iii) Harmonise clauses 12(5) with 4(2) such that the function of establishing standards and promotion of best practices and methods in statistical production should be at national level; this would ensure quality standards were maintained.



- iv) Rephrase clause 13 to provide the code of practice and setting out of professional standards was a mandate of KNBS and all county statistician shall adhere,
- v) Clause 15(3) should be deleted as it was ambiguous,
- vi) Clause 19 should be amended to provide for offenses and penalties for a person who fraudulently, dishonestly gives inaccurate or false information,
- vii) Provide an additional clause (clause 22) 'should any provisions of this Act be in conflict with the provisions of the Statistics Act, the provisions of the Statistics Act shall prevail, and
- viii) KNBS should be the depository for statistics including aggregated statistics from counties. Thus, there was need to provide a channel of information flow from counties to the KNBS.

#### **Observations**

The Committee made the following observations:

- a) There was need for a mechanism for harmonisation of information/ data collected separately by national government in a county and the county government;
- b) The channel of accessing data in the custody of the national government which county government may require to use as secondary data was not clearly provided;
- c) There should be linkage between the county statistics office and Kenya National Bureau of Statistics; and
- d) The function of establishing standards, procedures, methods and promotion of best practices in statistical production should be the mandate of KNBS.



#### **Recommendations**

In the view of the above observations and matters raised by the stakeholders, the Committee proposed the following amendments to the Bill;

#### CLAUSE 2

#### THAT clause 2 of the Bill be amended by-

(2A) The County Statistician may, in the case of an emergency, waive the requirement to submit an application under subsection (1).

## MIN. NO. 149/5/2018: SUBMISSIONS OF MEMORANDA ON THE COUNTY STATISTICS BILL, 2018

The Ag. Chairperson welcomed the members of the public to the meeting and this was followed with a round of introduction. He thereafter welcomed them to make their presentations.

#### Kenya Institute of Public Policy Research and Analysis (KIPPRA)

The representative informed the Committee that:

- a) The bill was to ensure that it promotes efficiency and consistency in the data collection as well as synergies between national and county government levels in implementing the 4<sup>th</sup> Schedule of the constitution,
- b) A clear policy framework would have played a key role in guiding such critical law as well as reviewing the Statistical Act, 2006,
- c) There was need for a well-planned coordination between national statistics and the county statistics by providing a clear mechanism to ensure efficiency, quality and timelines were not compromised especially where international standards and codes were required to be utilised,
- d) The Statistics Act which was under review needed to be aligned with the provisions in the County statistics bill,
- e) To ensure cost effectiveness the counties should adopt the already existing KNBS infrastructure including the international statistical systems and the human capital expertise,
- f) Clause 8 provided for consultative Committee which appeared as an independent organ with policy and oversight roles.
  - i) That introduced another layer of statistical administration of which it was not clear how its decisions would reach the counties.
  - ii) Proposed that the role should remain within the county executive with proper coordination with KNBS.
- g) Clause 12(5) failed to recognise that statistical standards and procedures were set internationally, like common wealth countries statistical standards and procedures. The county statistician should only adopt the existing standards and procedures,
- h) Clause 14 its application would stifle statistic collection and analysis in the county. Secondly, three months' notice requirement may delay and make research work cumbersome and expensive,

- i) Clause 18(2) it was not clear why the county statistics report would be shared with KNBS. Further, how would the discrepancies and aspects of timeliness be resolved?
- j) The role of county assembly in statistical process was not well defined other than receiving the annual reports,
- k) The role of counties during periodic national surveys was not defined and
- Proposed amendments of Statistic Act, 2006 to strengthen KNBS and mandate it to decentralize and coordinate counties to collect statistics. Further, provide mechanism to link county statistics with national statistics.

#### The Ministry of National Planning – Kenya National Bureau of statistics (KNBS)

The representatives informed the Committee that:

- a) the bill was important in that it aimed at providing establishment of county statistics which was a critical unit at county level;
- b) production of accurate statistics was important since they facilitate proper planning,
- c) the bill had a few issues which they proposed amendments as follows-
- *i)* clause 4(c) be amended to replace *'official bodies'* with *'coordinating the operations of the county in compilation and dissemination of statistics and related information with particular regard to'*
- ii) clause 8
  - ✓ replace the name of the Committee with 'Inter-Governmental Consultative Committee on Statistics'
  - ✓ (a) should be deleted since the Committee was technical: county governor need not be the Chairperson.
  - ✓ (b) principal Secretary, State Department responsible for Statistics to chair the Committee
  - ✓ (4) be deleted since KNBS may not be in a position to provide resources to support the Committee.
- iii) Harmonise clauses 12(5) with 4(2) such that the function of establishing standards and promotion of best practices and methods in statistical production should be at national level; this would ensure quality standards were maintained.
- iv) Rephrase clause 13 to provide the code of practice and setting out of professional standards was a mandate of KNBS and all county statistician shall adhere,
- v) Clause 15(3) should be deleted as it was ambiguous

- vi) Clause 19 should be amended to provide for offenses and penalties for a person who fraudulently, dishonestly gives inaccurate or false information,
- vii) Provide an additional clause (clause 22) 'should any provisions of this Act be in conflict with the provisions of the Statistics Act, the provisions of the Statistics Act shall prevail and
- viii) KNBS should be the depository for statistics including aggregated statistics from counties. Thus, there was need to provide a channel of information flow from counties to the KNBS.

We had previously given comments on this Bill and appreciate the fact that most of the comments were taken into account. We are grateful to the drafters for incorporating the comments.


Statistics is very relevant and of great importance in our society. We cannot plan without accurate statistics. For this reason, we support the production of accurate statistics in our country.



## SUBMISSION ON THE COUNTY STATISTICS BILL 2018

### KIPPRA COMMENTS ON COUNTY STATISTICS BILL

The Bill demonstrates a commitment to facilitating the public policy process with data. By embracing data collection at the county level this will help in guiding the regulatory and policy frameworks that support in contributing to the development agenda. That said, given that the Bill defined the rule of the game we need to ensure that it promotes efficiency and consistency in the data collection as well as enhancing synergies between the national and county government levels in implementing the 4<sup>th</sup> schedule. In addition, a clear policy framework would play a key role in guiding such a critical law as well as concurrent review of the Statistical Act 2006.

- 1. The 4<sup>th</sup> schedule of the 2010 constitution defines the distribution of functions between the National and County governments where;
  - a. National Government, part 1, article 11, deals with "National Statistics and data on population, the economy and society in general; while
  - b. County Government, part 2, article 8, deals with "County planning and development, including (a) statistics, (b)...."

This calls for a well-planned coordination between national statistics and the county statistics as each county statistics should inform the national statistics. If these statistics are collected and managed by independent institution, then there must be clear mechanisms to ensure efficiency, quality and timelines is not compromised particularly where international standards and codes are required to

be utilized. For example, it is not clear the role of the KNBS in <u>collating the statistics</u> provided by the counties, and the support that it will be getting in gathering its statistics that cut across the counties. Similarly, is how the resources at national county level can be effectively harnessed especially given the elaborate KNBS structures that exist at the moments.

- 2. KNBS is under Statistics Act, 2006 and this bill need to refer to it exhaustively for consistency purposes. The Act is undergoing a review to capture the 2010 constitution and other dynamics in statistics and in the country. This may bring out clarity.
- 3. It would be important and cost effective for the counties to use the already existing KNBS infrastructure that even include the latest international statistical systems and the human capital expertise in the KNBS. For example, KNBS has already established system with which it collects data across the country. It is not clear whether the counties will establish parallel systems.
- 4. Article 8, in part III, has a consultative committee which gives another layer of statistical administration. It appears this is an independent organ with policy and oversight roles. It is not clear how decisions made at the committee reach to all counties given that not all counties are represented. Such a layer can influence the efficiency of collection and handling statistics. This should remain with the county executive and a proper coordination with the KNBS.
- 5. Article 12 (5) refers to standards and procedures determined by the Statistician this is not in order as statistical standards and even procedures already have international standards provided for by all the common wealth countries. Thus, the county is only expected to adopt the standards which are normally updated as new demand arises through a consultative process. The county statistician should only monitor but not determine.
- 6. Article 14 having the statistician approving conduct of statistical surveys in the county, may stifle statistic collection and analysis in the country. A central coordination role need to exist and rather the statistician approving the process, the statistical office need to be approving these statistical requests. The three-month notice to be given to each county may delay and make research work cumbersome and expensive.
- 7. 18(2) the county statistics report to be shared with KNBS. Will KNBS be publishing the data together with the national statistics. Suppose there are discrepancies how

- 8. The role of the county assembly in the statistical process in the county is not clearly defined apart from receiving the annual reports.
- 9. It is not clear the role of the counties when it comes to periodic national surveys including surveys and censuses.
- 10. To note 4(a & b) the functions of the County Statistics Office are similar to KNBS Act Statistical 2006.
- 11. Finally, it is important that the statistical policy framework for Kenya guides both the national and county government. It also means amending the Statistics Act for 2006 to capture all the dynamics including the statistical processes and coordination roles in the country.
